Leadership Council Structure

The SIMPL Collaborative Leadership Council (Leadership Council) is an advisory body comprised of approximately 24 stakeholders that will be convened by SHRA. The Leadership Council is built to provide guidance and resources to ensure the projects funded by the Transformative Climate Communities (TCC) grant are on track and outcomes are achieved or exceeded (Attachment A). If projects are stalling or organizations are not performing, these issues will be raised with the Leadership Council, which will evaluate the situation and provide options for resolution. Individuals/Organizations may petition to sit on the Leadership Council by sending in a letter of interest. If all seats are filled, a new seat can be created by 2/3 vote of the existing Leadership Council.

SHRA, with assistance from the Co-Applicants, is responsible for the success of the SIMPL Project activities.

All substantive changes or material issues related to implementing the SIMPL Project shall be presented to the Leadership Council. As an Advisory Body, the Leadership Council will make recommendations and suggest alternatives.

The Leadership Council will have voting power and can make recommendations for the initiative, however SHRA will have the final decision-making power as the Lead Applicant.

Term

Recommended and at-large Leadership Council members shall serve a term of two years and may be recommended or reapply to serve another term during the five-year grant funding period. The proposed term limit must be approved by the newly created Leadership Council and is subject to change.

Meetings, Frequency and Purpose

The Leadership Council will meet once a month for the first six months of Grant establishment, starting within a month of notice of Grant Award. The Leadership Council will determine if it needs to continue to meet monthly after six months or move to a regular quarterly calendar. Once all Initiatives, Working Groups and communication processes are fully established, the Leadership Council will meet on a quarterly basis to discuss progress on all aspects of TCC proposal implementation, provide guidance on approach, develop parameters for success; and ensure that the projects and programs integrate with each other and connect with additional efforts in the neighborhood. The Leadership Council brings together key community stakeholders that can help to address issues that arise from both a policy perspective, as well as provide insight into the grassroots needs of the community. These organizations represent the ability to problem-solve with financing, legislation and human capital.

Meeting Times and Location

The Leadership Council will determine meeting times and location. Each meeting shall have an agenda with sufficient time dedicated to each agenda item for full consideration and participation from the Leadership Council. Meetings shall be run in regular order with the Chair recognizing speakers to allow for an organized exchange of ideas. Meetings will be scheduled at convenient times (e.g., after work) and convenient and accessible locations, with translation upon request and services for people of all ages and abilities, and childcare as necessary.
